AMDG President's Report April 2026

Haec olim meminisse iuvabit
(Virgil, *Aeneid* I.203)

As I come to the end of my term as President of the Stonyhurst Association, this report is an opportunity to set out, in practical terms, what has been happening across the Association over the past year – and, more importantly, the extent to which it reflects the values we talk about so often. It has been a busy year.

Association events—both formal and informal—have been well supported. Thirst Fridays continue to do exactly what they are supposed to do: bring OS together without ceremony or complication. From York, ably marshalled by Chris Thorpe OS 82, to our first gathering in Tokyo, these events demonstrate that the Association sometimes work best when it simply creates the conditions for people to reconnect.

Internationally, the Association has continued to strengthen its reach. In Spain, Jimmy Burns OS 71 and Brian Douglas OS 83 have been instrumental in building momentum, with well-attended gatherings in Madrid bringing together a diverse group of OS and reinforcing ties with the College and the wider British-Spanish network. Similar momentum is evident elsewhere, with gatherings and networks developing across Munich, Lisbon, Singapore and Hong Kong. These are not centrally driven initiatives—they are locally led, and all the more effective for it.

At home, key events in the calendar have continued to play an important role. The Association Dinner remains our most important fixture, and I am pleased that the next Dinner will return to the College. Newer initiatives such as the OS Military Dinner have brought together OS with shared experiences of service, reinforcing bonds that extend well beyond schooldays.

A particular focus over the past two years has been engaging younger OS—both those who have recently left the College and those still at Stonyhurst. That has taken a number of forms: encouraging attendance at events,

building sport-led engagement, and ensuring that the Association is visible and relevant before pupils leave, rather than something rediscovered years later.

Alongside these more visible activities, a significant amount of work continues behind the scenes. In particular, the Association's ability to support members in need remains central. Over the past year, the President's Fund has been used to provide practical assistance in a number of cases, where OS have found themselves in financial or emotional trouble and have needed the support of the President's Fund in addition to welcome support from OS contemporaries. This is not headline activity, nor should it be—but it is fundamental to the purpose of the Association.

There have also been a number of moments during the year that have reinforced the broader identity and heritage of the Stonyhurst community. The pilgrimage to Lourdes and the Easter Retreat remain key examples, bringing together OS, College pupils, families and friends in a shared purpose of reflection, service, companionship and prayer.

Beyond the Association itself, it has been encouraging to see the continued impact of OS across a wide range of fields. One particularly striking example is the work of an OS with the Italian Red Cross in Rome, coordinating efforts to reunite families separated by conflict and migration—connecting individuals across continents, arranging documentation, and, in some cases, bringing families back together after years apart. Alongside this, we see OS contributing in business, public life, education and the charitable sector.

It would also be remiss not to acknowledge the College itself. This year has seen the handover from John Browne, to whom we owe a considerable debt of gratitude for his leadership and stewardship of Stonyhurst over many years. Under his tenure, the College has navigated a challenging period for the independent education sector and remains in a strong financial position. It continues to stand as the leading Catholic boarding school, with a clear sense of identity and purpose. We wish his successor, Mr William Doherty, every success, and the Association will be there to support him.

None of this would be possible without the efforts of a small number of committed individuals. Jo-anne Brown and Layla Heaton have ensured the smooth running of the Association throughout the year. Brendan Roche OS

82, Gerry Lagerberg OS 79, and the wider Committee have provided consistent support and guidance, while many others have contributed by organising events, leading initiatives, or simply turning up and taking part.

I will be handing over to Jonty Warneken OS 90 in May. Jonty brings considerable energy, perspective and vision to the role, and I have no doubt that the Association will continue to develop under his leadership.

Looking back, what stands out is not any single event or initiative, but the consistency with which OS continue to support one another—whether through sport, social connection, professional networks, or more quietly in times of need.

In an increasingly divided and uncertain world, the values of Stonyhurst feel more relevant than ever. *Men and Women for Others, Quant Je Puis*—these are not simply mottos, but a way of approaching life. They call on us to act, to contribute, and to take responsibility beyond ourselves – *Ad Majorem Dei Gloriam*.

If the Association can continue to embody those values, then it is far more than a mere alumni network. It is a genuine force for good in the world.
